### Complete and send the Stock Donation **LETTER OF INTENTION**.

**ALL STOCK DONATIONS MUST BE ACCOMPANIED BY** a stock donation **Letter of Intention** form (see page 3).

## SECURITIES & STOCK CERTIFICATE(S) DONATION

### Transfer Stock/Securities

For your convenience, you can transfer securities electronically, by registered mail, or via in-person delivery.

#### 1. **ELECTRONICALLY** - To transfer the securities electronically:

#### 2. **REGISTERED MAIL** - To transfer the stock certificate by Registered Mail:

- Stock certificate(s) in the name of the parish, school, or agency can be sent to us without a signature or irrevocable stock bond power. Place the Stock Certificate(s) and the stock donation Letter of Intention in an envelope and send via **REGISTERED MAIL**.

- Stock certificate(s) in the Donor's name - **DO NOT SIGN** the stock certificate(s). Send the Stock Certificate(s) to us in one envelope via Registered Mail. In a separate envelope send a completed, signed and dated irrevocable stock bond power form, together with the completed stock donation **Letter of Intention** (see page 3 for mailing address).

3. **IN-PERSON DELIVERY** - To deliver the securities (stock certificate) in person:
- **DO NOT SIGN** the stock certificate(s).
  - Contact the Archdiocesan Bank at (312) 534-5399 to arrange a time to deliver the stock certificate(s), irrevocable stock bond power and stock donation **Letter of Intention**.

**Please note: Stock Certificates received stamped "RESTRICTED" will experience longer processing times.**
